# RULES FOR THE CLASSIFICATION AND CONSTRUCTION OF PLEASURE CRAFT, 2012, ND No. 2-020101-071-E

### PART I. CLASSIFICATION

#### 2 CLASS OF A CRAFT

Para 2.1.4 shall be amended to read:

"Class to the pleasure craft shall be assigned or renewed by the Register for 5-year period, provided that intermediate survey is performed during the specified period for the confirmation of the craft class validity.

Periodical surveys of the pleasure craft shall be assigned taking into account the following:

special survey, including survey of the outside of the craft bottom in dry dock, on a slipway or ashore, shall be carried out at intervals not exceeding 5 years to renew the class for the next five-year period;

intermediate survey of the craft shall be carried out between the second and third anniversaries of special survey, i.e. during the third year after performance of special survey or initial survey for the craft registration.

Where reasonable, the Register may assign or renew the class for shorter period.

There shall be a minimum of two surveys of the outside of the craft bottom during five-year period of the Classification Certificate validity. One such survey shall be carried out during special survey. In all cases the interval between two such surveys shall not exceed 36 months (between two subsequent special surveys).

Unless shorter periods are provided in as-built or operating documentation, survey of the outside of the craft bottom of non-self-propelled and berth-connected craft shall be carried out in compliance with 2.5.5, Part II "Survey Schedule and Scope" of the Rules for the Classification Surveys of Ships in Service.

Possible performance of in-water survey in lieu of survey of the outside of the craft bottom in dry dock, on a slipway or ashore shall be determined by the Register (refer to 2.5, Part II "Survey Schedule and Scope" of the Rules for the Classification Surveys of Ships in Service)."
