17.3 TECHNICAL SUPERVISION DURING MANUFACTURE OF POLLUTION PRVENTION EQUIPMENT UNDER ESTABLISHED PRODUCTION CONDITIONS

- 1 **Para 17.3.15** is renamed reading as follows:
- "17.3.15 Exhaust gas cleaning systems and NO_x-reducing devices.".
- 2 In **Para 17.3.15.1** the first sentence is replaced by the following text:
- "17.3.15.1 The testing of the exhaust gas cleaning systems and NO_X -reducing devices shall be carried out in compliance with the requirements of the Guidelines (refer to IMO resolutions MEPC.259(68), MEPC.291(71) and MEPC 307 (73), as applicable).", the rest remaining as it stands.
