3 ANCHOR ARRANGEMENT

1 **Para 3.3.1** is replaced by the following text:

"3.3.1 The weights of anchors listed in Tables 3.2.1-1 and 3.2.1-2 refer to anchors of the high holding power.

In order to acknowledge an anchor as a high holding power anchor it is necessary to carry out tests following the approved Test program. The requirements for manufacture of anchors are given in Section 3, Part III "Equipment, Arrangements and Outfit" of the Rules for the Classification and Construction of Sea-Going Ships and 3.5, Part IV "Technical Supervision during Manufacture of Products" of the Rules for Technical Supervision during Construction of Ships and Manufacture of Materials and Products for Ships."
