Text of CL:

We hereby inform that the Rules for the Classification and Construction of Sea-Going Ships shall be amended considering experience in application of the Rules.

It is necessary to do the following:

1. Bring the content of the Circular Letter to the notice of the RS surveyors, interested organizations and persons in the area of the RS Branch Offices' activity.
 2. Apply the provisions of the Circular Letter during review and approval of the technical documentation on machinery intended for ships contracted for construction or conversion on or after 01.09.2020, in the absence of a contract, the keels of which are laid or which are at a similar stage of construction on or after 01.09.2020.

PART IX. MACHINERY

1 GENERAL

- 1 **Table 1.2.3.1-1.** The text of the first item is replaced by the following text:

"Internal combustion engine particulars (refer to Appendix 3 "Internal Combustion Engine Type Approval Application Form and Basic Data Sheet" to Section 5 "Machinery", Part IV "Technical Supervision during Manufacture of Products" of the Rules for Technical Supervision during Construction of Ships and Manufacture of Materials and Products for Ships) or Technical Specification."

- 2 **Para 1.6.1** is replaced by the following text:

"1.6.1 Unless otherwise specified, materials intended for manufacture of the machinery parts may be manufactured by the RS rules and shall comply with the requirements stated in column 4 of Table 1.2.4 of the appropriate chapters of Part XIII "Materials" or by international and national standards as per form of technical supervision of Group 1M (Table 5.2-2, Part I "General Regulations or Technical Supervision" of the Rules for Technical Supervision during Construction of Ships and Manufacture of Materials and Products for Ships).

The application of materials manufactured by standards, is subject to agreement with the Register during consideration of the technical documentation."

- 3 **Para 1.6.2** is replaced by the following text:

"1.6.2 Unless otherwise specified, materials of the parts of internal combustion engines are subject to survey by the Register in accordance with Appendix 8 to Section 5, Part IV "Technical Supervision During Manufacture of Materials" of the Rules for Technical Supervision During Construction of Ships and Manufacture of Materials and Products for Ships.

At the discretion of the Register the survey may also be required during manufacture of pipes and valves of the pressure systems associated with the engine."
