We hereby inform that the Rules for the Classification and Construction of Sea-Going Ships shall be amended as specified in the Appendices to the Circular Letter.

It is necessary to do the following:

1. Bring the content of the Circular Letter to the notice of the RS surveyors, as well as interested organizations and persons in the area of the RS Branch Offices' activity.
 2. Apply the provisions of the Circular Letter during review and approval of the technical documentation on ships contracted for construction or conversion on or after 01.11.2020, in the absence of a contract, the keels of which are laid or which are at a similar stage of construction on or after 01.11.2020, or during review and approval of technical documentation and performing technical supervision during manufacture of products requested on or after 01.11.2020.

4 DISTRIBUTION OF ELECTRICAL POWER

"**4.6.2.7** Busbars and uninsulated conductors of different polarity or of different phases shall be marked with distinguishing colours in accordance with IEC 60445:2017 or national standards."
