Text of CL:

We hereby inform that the Rules for Technical Supervision during Construction of Ships and Manufacture of Materials and Products, 2021, ND No. 2-020101-139-E shall be amended, considering the experience of technical supervision, as specified in the Appendices to the Circular Letter.

It is necessary to do the following:

1. Bring the content of the Circular Letter to the notice of the RS surveyors, interested organizations and persons in the area of the RS Branch Offices' activity.
 2. Apply the provisions of the Circular Letter during review and approval of the technical documentation on the shafting components and propellers intended for the ships contracted for construction or conversion on or after 01.05.2021, in the absence of a contract – on ships, the keels of which are laid, or which are at a similar stage of construction on or after 01.05.2021, as well as during review and approval of the machinery installations requested for survey on or after 01.05.2021.

PART IV. TECHNICAL SUPERVISION DURING MANUFACTURE OF PRODUCTS

6 SHAFTING COMPONENTS

1 **Para 6.1.8** is replaced by the following text:

"6.1.8 The materials, related equipment, blanks and components used for the manufacture and completing of the items and products which have to be subjected to the technical supervision shall have marking and documents confirming the Register technical supervision during the manufacture thereof in accordance with the RS Nomenclature."

7 PROPELLERS

2 **Para 7.1.8** is replaced by the following text:

"7.1.8 When finished components are delivered to a firm from a supplier, check shall be carried out for availability of the documents according to the RS Nomenclature and technical supervision form. During the external examination of the propellers and their components, the following shall be checked: compliance of the documents with the adopted supervision form, measurement cards, absence of defects."
