Text of CL:

We hereby inform that the Guidelines on Application of Provisions of the International Convention on Load Lines (ICLL 66/88/20003) shall be amended as specified in the Appendices to the Circular Letter.

It is necessary to do the following:

1. Bring the content of the Circular Letter to the notice of the RS surveyors, the RS Branch Offices, interested organizations and persons in the area of the RS Branch Offices' activity.
2. Apply the provisions of the Circular Letter during review and approval of the technical documentation on ships contracted for construction or conversion on or after 01.09.2023, in the absence of a contract, on ships, the keels of which are laid, or which are at a similar stage of construction on or after 01.09.2023, as well as during review and approval of the technical documentation on ships, the delivery of which is on or after 01.09.2023.
3. Apply the provisions of the Circular Letter during review of the technical documentation on ships under construction and in service upon applications by the interested parties.
