Text of CL:

We hereby inform that the Rules for Technical Supervision during Construction of Ships and Manufacture of Materials and Products for Ships shall be amended as specified in the Appendices to the Circular Letter.

It is necessary to do the following:

- 1. Bring the content of the Circular Letter to the notice of the RS surveyors, interested organizations and persons in the area of the RS Branch Offices' activity.
- 2. Apply the provisions of the Circular Letter during review and approval of the technical documentation on products as well as when performing technical supervision during manufacture of products, when the requests for service rendering listed above are received on or after 15.04.2022.
- 3. Apply the provisions of the Circular Letter during review and approval of the technical documentation on ships (or during survey of ships) under construction from the entry-into-force date of amendments.

## PART II. TECHNICAL DOCUMENTATION

#### 8 PREPARATION OF RESULTS OF TECHNICAL DOCUMENTATION REVIEW

1 **Para 8.1** is replaced by the following text:

**\*8.1** Depending on the type of documentation, the results of the technical documentation review by the Register are finalized by appropriate stamping of the documents and/or drawing up a conclusion letter.

When reviewing the technical documentation in electronic form, stamping is carried out by software tools and is certified by digital signature of the Register authorized specialist.

In case of a single approval of technical documentation simultaneously with the survey of products without compiling a conclusion letter, it is allowed to put the surveyor's stamp on the front page of the approved documentation with indication of the date of review and application number pursuant to which the documentation was reviewed.".
