## **COMMON STRUCTURAL RULES FOR BULK CARRIERS AND OIL TANKERS**

---

Common Structural Rules for Bulk Carriers and Oil Tankers have been approved in accordance with the established approval procedure and come into force on 1 July 2022.

On entry into force, the present Rules replace the Common Structural Rules for Bulk Carriers and Oil Tankers, 2021.

The text of the present Rules is identical to that of the IACS Common Structural Rules for Bulk Carriers and Oil Tankers 2022 (Effective date 1 July 2022)<sup>1</sup> and this is consolidated edition including:
